

# Terms & Conditions

PLEASE READ THE FOLLOWING CAREFULLY BEFORE ACCESSING AND/OR USING ANY PART OF THE SITE. Welcome to [www.usdietalert.com](http://www.usdietalert.com) (together with its subdomains, Content and Marks, the “Site”).
